## RECORD: Plaintiff wants to make some Reditus finances public

PEKIN, Ill. (WMBD) — The legal battle continues between [Reditus Laboratories](#) CEO Dr. Aaron Rossi and his business partner, Dr. James Davie.

Rossi is being sued by Davie, of Davie and Associates Dermatopathology, P.A., for access to financial documents associated with the company.

According to court documents, Davie’s attorney, Peter Lubin, filed a motion related to the protective order to allow the second amended complaint to become part of the public record.

Davie and Associates Dermatopathology believes that the public, including the citizens of Pekin who loaned Reditus Labs Money to get its COVID-19 testing business off the ground, have the right to learn, “the facts regarding Rossi’s ‘Theft & Waste’ and destruction of Reditus Labs.”

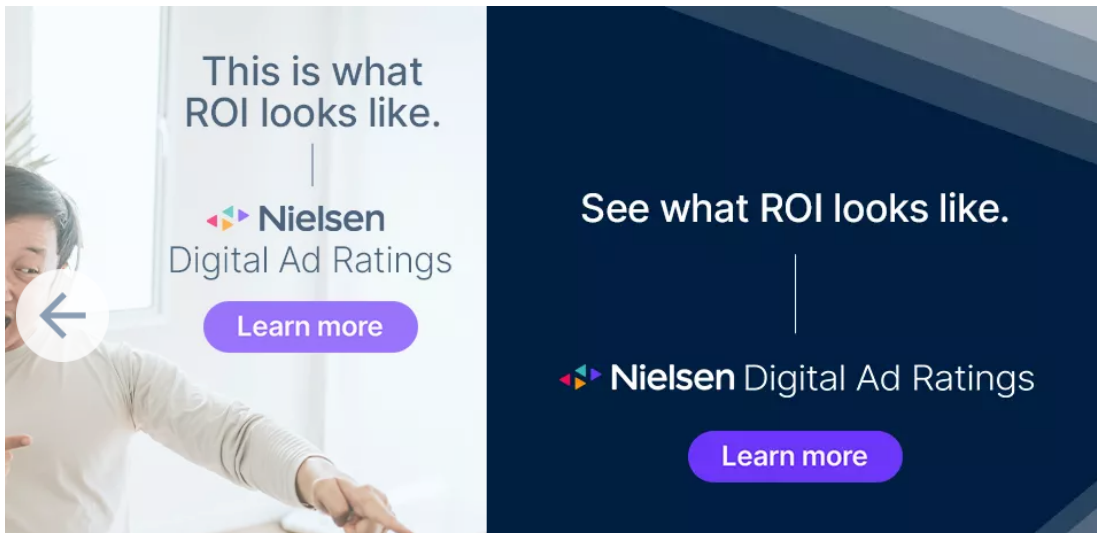
